BUILDING PROJECT TASK FORCE – Bill Luria

Updated the board about the Building Project Task Force. Members of the Task Force were introduced: Bill (Chair), David, Mimi, Eleanor, Gerry, Colleen, Del Miller and Reed. Outlined the tasks and activities that have to take place. Three of the most critical priorities right now:

 Receiving the MOU from COBI. Without it we cannot executed a long-term ground lease (minimum 35 years). And without the long-term ground lease there is no project.
 We are about 6 weeks behind what was promised and would like to give the city one or two more weeks to provide it.

• Funding -

- We have a signed contract with Ostara to provide a comprehensive feasibility study. Mimi is working directly with Amy Besuder from Ostara, to gather materials Ostara has asked for as they will conduct limited internal assessment and audit of development activities, systems, and processes to determine unmet needs to manage the campaign including a recommended staffing and volunteer structure.
- Winslow Architects are moving to the next phase. They are working on 3 or 4 different locations on the current 5+ acre site. Proposals will come to the board
- Board All board members are asked to provide a list of people in the community that
 may be influencers or major donors or both. It would be best if board members advised

 by September 25. If a board member would like Reed to talk to their contact in advance
